## Motion to

the Annual General Meeting of Powszechny Zakład Ubezpieczeń Spółka Akcyjna

### about certain amendments to the Articles of Association of Powszechny Zakład Ubezpieczeń Spółka Akcyjna

#### Contents:

We hereby request the Annual General Meeting to adopt a resolution about certain amendments to the Articles of Association of Powszechny Zakład Ubezpieczeń Spółka Akcyjna intended to clarify the names of local business units of PZU SA in the Articles of Association for the purpose of the development of a new local organisational structure of the Company.

## Rationale:

Under Article 430 § 1 of the Polish Commercial Companies Codes, it is within the authority of the Annual General Meeting of the Company to make amendments to the Company's Articles of Association. Under § 16 section 1 item 1 of the Articles of Association of PZU SA, a resolution about amendments to the Articles of Association is adopted by a three-fourths majority vote.

The proposed amendments are intended to clarify the existing provisions in the Articles of Association and involve changes to local structure names, including the change of the name of the "branch office" local business unit to "regional branch office", as part of the development of a new organisational structure of local business units.

The proposed amendments to the Articles of Association do not affect the authority of any statutory body of the Company. Under § 25 section 2 item 16 of the Articles of Association, the Supervisory Board shall continue to have the authority to express its approval for the establishment and discontinuation of branches of PZU SA entered in the National Court Register, and such branches shall be called "regional branch offices". The Supervisory Board shall also continue to have the authority to express its approval for the establishment and discontinuation of foreign branch offices.

The proposed amendments to the Articles of Association:

1) in § 2, section 2 of the Articles of Association in the following wording:

"2. The Company may establish and operate its branch offices in the Republic of Poland and abroad."

shall read as follows:

"2. The Company may establish and operate in the Republic of Poland its regional branch offices which should be disclosed in the Register of Businesses of the National Court Register, and foreign branch offices.";

2) in § 25, section 2 item 16 in the following wording:

"16) approval for the establishment and discontinuation of branch offices;"

shall read as follows:

"16) approval for the establishment and discontinuation of regional branch offices referred to in

§ 2 section 2, and of foreign branch offices;".

A draft resolution of the Annual General Meeting about the amendments to the Articles of Association of Powszechny Zakład Ubezpieczeń SA is presented as an appendix to this motion.

On ...... 2010, the Supervisory Board adopted Resolution No. URN/.../2010 about the approval of the Motion of the Management Board addressed to the Annual General Meeting of PZU SA about the amendments to the Articles of Association of Powszechny Zakład Ubezpieczeń Spółka Akcyjna.

In accordance with the Polish Insurance Act, the amendment to § 25 section 2 item 16 will need to be approved by the Polish Financial Supervision Authority.

Therefore, we request the Annual General Meeting of PZU SA to adopt a resolution about the amendments to the Articles of Association of Powszechny Zakład Ubezpieczeń Spółka Akcyjna.
