Subject: **Notification from BlackRock, Inc. on its shareholding in the share capital of and in the total number of votes of PZU SA**

Legal basis: Article 70(1) of the Act on offerings – acquisition or disposal of significant equity stakes

Body of the Report:

The Management Board of Powszechny Zakład Ubezpieczeń Spółka Akcyjna (“PZU SA”, “the Company”) provides the following notification as an attachment, received by the Company from BlackRock, Inc. informing that as a result of the sale of PZU SA’s shares on 20 October 2025, the total shareholding of BlackRock, Inc. in the share capital and in the total number of votes at the General Shareholder Meeting of PZU SA (“GSM”) as of 21 October 2025 is 4.99%.

According to the notice in question, before the transaction was settled, BlackRock, Inc. had held a total of 43,298,802 PZU SA shares, corresponding to 5.01% of the Company’s share capital and entitling to exercise 43,298,802 votes, representing 5.01% of the total number of votes at the Company's GSM.

After the settlement of the transaction BlackRock, Inc. has 43,136,798 PZU SA’s shares, representing 4.99% of the Company’s share capital, which gives the right to exercise 43,136,798 votes attached to PZU’s shares representing 4.99% of the total number of votes at the Company's GSM.

The full text of the notification is attached to the report.

Legal basis: Article 70(1) of the Act on Public Offerings – the Act of 29 July 2005 on Public Offerings and the Conditions for Offering Financial Instruments in an Organized Trading System and on Public Companies.
